Subdivision Restrictions and Homeowners Association By-Law Review

Is there anything you'd like to see changed in the Subdivision Deed Restrictions or HOA By-Laws? *Well, do we have an opportunity for you!* You are welcome to participate in a homeowners group that will be reviewing the documents (yawn!) this summer/fall. To be part of the group you need to commit to reading the documents, providing feedback, and reviewing the input from others. Most of the group's work will be done through email with limited in-person meeting time required. The final recommendations will be provided to the HOA Board.

If you have thoughts or opinions on the Restrictions or By-Laws but can't commit to being an active part of the group, you can provide your input for their consideration.

Who is responsible for subdivision roads?

Our subdivision roads are public roads. Traffic enforcement is the responsibility of Hamburg Twp. The roads are deeded to Livingston county, and the county is responsible for maintenance of our subdivision roads. As with other subdivision roads in the county, if there are major repairs/ repaving work necessary, the cost is typically paid by the homeowners though an assessment billed along with your property taxes. We will be investigating further to better understand the process.

Trash Service

Homeowners have an opportunity to save money on their trash services while also potentially reducing the number of garbage trucks traveling through our subdivision. The Garbage Man (TGM), a locally owned company, currently serves 26 of our homeowners. If at least 32 WPH homeowners use TGM, they will provide a discounted rate to customers in the sub:

HOA Trash Pick-up Rates:

- \$57 per quarter if you use your own bin (currently \$75 per quarter, Non-HOA rates)
- Recycling is available for an additional charge (no discount)

If interested, contact TGM to sign up for service. To ensure you are included in our subdivision customer count, mention West Point Hills Subdivision HOA when signing up.

This initiative not only saves money but could also reduce the number of garbage trucks in our neighborhood, benefiting our roads and overall environment.

Please Note: This offer is extended to individual homeowners within the subdivision by TGM. The HOA is not a party to any agreement between TGM and individual homeowners.

Neighbors not acting neighborly?

Hopefully not, but if it seems that way... Hamburg Twp Police hosted an HOA Open Forum to discuss some of the Township ordinances that apply.

The first question the officers will ask before undertaking any enforcement activity is "Have you talked to your neighbor about this?" We also encourage you to discuss problems with your neighbor(s) directly before escalating any issue.

Some of items covered in their presentation:

Animal control



» Animals must be on a **6 foot (max) leash** on public property (roads, sidewalks)

Barking must not be audible beyond property at night, or **beyond 100 ft away from property** during the day

Noise Restrictions

» NO operating Lawn Equipment or Construction between 10pm and 7am



» Speakers/Amplifiers should not be plainly audible off property from 10pm -7am, or 100 ft beyond property line from 7am–10pm

» Camp fires are allowed with the following restrictions:

April, May, October and November with the following

burn area is not to exceed 8 ft in diameter/square

» Open burning is allowed from sunrise to sunset,

> extinguishing equipment must be available

» No Fireworks **before 11am or after 10pm** other days

» Motorcycles, ATVs, trail bikes, etc. may not be operated

on private property within the subdivision.

3 ft in diameter

> must monitored by a sober adult

burning in the street is not allowed

4th of July Fireworks Restrictions

» Fireworks are prohibited before 11am or

after 11:45pm on June 29th-July 5th

> must be greater than 10 ft from property line

> must be contained in a fire ring no larger than

- Please pick up what your dog leaves behind.

- Coyote Sightings Keep an eye on your outside animals.
- **Construction Residue** Lots of roofs replaced \rightarrow lots of old (and
